#### Introduction

#### **Services Provided**

### **Payment Terms**

- **Deposit Requirement:** A deposit equating to 50% of the total funeral invoice is required. This deposit must be received by Wyatt Brothers Funeral Directors Ltd at least 48 hours prior to the funeral service.
- **Invoice Payment:** Clients are kindly asked to settle their invoice within 14 days from the invoice date unless an alternative arrangement has been previously agreed upon with your funeral director. We reserve the right to impose an interest charge of 2% per calendar month on any account that remains outstanding beyond this period.
- Payment Methods: Payments can be made by card (debit or credit), cash, via cheque, or by BACS transfer, all payable to Wyatt Brothers Funeral Directors Ltd. If the account is being managed by a bank or solicitor, please inform us at your earliest convenience to ensure seamless processing.

# **Cancellation Policy**

Clients have the right to cancel the funeral arrangements. Notice of cancellation must be provided in writing. If cancellation occurs within 14 days of the agreement, any deposit paid may be subject to partial or full refund depending on the costs already incurred by Wyatt Brothers Funeral Directors Ltd on behalf of the client. Services commenced prior to cancellation notice will be charged accordingly.

# Disbursements

Disbursements are payments that we make on behalf of our clients for third-party services related to the funeral. These can include fees payable to doctors, ministers or celebrants, crematoriums, or cemeteries, and are additional to our service charges. We will provide an estimate of these external fees, which will be included in the initial cost estimate of the funeral service.

#### **Confidentiality Agreement**

We are committed to maintaining the confidentiality of all personal information entrusted to us, except as required by law or as necessary to provide the contracted funeral services. All employees and contractors of Wyatt Brothers Funeral Directors Ltd are bound by confidentiality agreements to ensure the privacy and security of your information.
